

Website Privacy Policy

1. Introduction

- 1.1 This Policy describes how Attain Academy Partnership (herein referred to as the 'Trust'), its Academies and Strategic Partners safeguards the information of our website visitors. It explains how we comply with the GDPR (General Data Protection Regulation), the DPA (Data Protection Act 2018) and the PECR (Privacy and Electronic Communication Regulations).

- 2.2 Personal Data collected through our websites is not shared with everyone listed in this Privacy Notice. We only use and share data required for that particular function and only the minimum required.

3. What personal data we collect and how we use this data

- 3.1 We may collect website usage data. This may include cookies, IP address, geographical location, browser type and version, length of visit, page viewed and website navigation paths). The usage data may be processed for the purposes of analysing website use. The legal basis for this processing is our public interests, i.e. monitoring and improving our websites.
- 3.2 We may collect personal information through website Online forms, such as Booking Forms and 'Contact Us' Forms. This may include information such as name, job title, contact information including email address and other information relevant to client enquires. The legal basis for processing is our public interest and/or contractual purposes i.e. to respond to queries or manage bookings. Specifically, we may use the data
 - For our own internal records
 - To improve the service and products we provide
 - To contact you in response to a specific enquiry

Where collected, the personal information will not be collected without your express consent and will only be used in the ways described in this policy. The following

3.3 We may collect personal information when you choose to register an account on the website. This will include name, username, password and email. We may also collect additional information such as IP address, operating system or browser information when you interact with the website. The legal basis for processing is our public interest to ensure a valid logging on process for registered users and to ensure the security and authenticity of registered users and their data. 3.4 Where we have clearly stated and made you aware of the fact, and where you have given your express permission, we may use your details collected through the websites to send you promotional emails about products/service and other things we think might be of interest to you. This is done in accordance with the regulations named in this policy. The legal basis for this processing is our legitimate interests, namely the proper administration of our communications with users.

3.5 We may process information contained in or relating to any communication that you send to us. The correspondence data may include the communication content. The correspondence data may be processed for the purposes of communicating with you and record-keeping. The legal basis for this processing is our public interest interests, namely the proper administration of our communications with users.

3.6 We may process any of your personal data identified in this policy where necessary for the establishment, exercise or defence of legal claims, whether in court proceedings or in an administrative or out-of-court procedure. The legal basis for this processing is necessary for compliance with a legal obligation to which the controller is subject.

3.7 We may process any of your personal data identified in this policy where necessary for the purposes of obtaining or maintaining insurance coverage, managing risks, or obtaining professional advice. The legal basis for this processing is our legal obligation to protect our school against risks.

3.8 In addition to the specific purposes for which we may process your personal data set out in this Section 3, we may also process any of your personal data where such processing is necessary for compliance with a legal obligation to which we are subject, or in order to protect your vital interests or the vital interests of another natural person.

4. Data Sharing

4.1 Any data provided through online forms are sent directly to the Academy or Partner concerned. We will not disclose personal data to any Third Party outside of the Trust. We may disclose it within the Trust.

5. Retaining and deleting personal data

5.1 Personal data is kept for as long as it is required to fulfil the purpose for which it was collected after which time, subject to any exceptions laid out in the Attain Academy Partnership Data Protection Retention Policy, the data will be deleted. The Trust's Data Retention Schedule may be found on the Trust and the Academies/Strategic Partners websites.

6. Cookies and how we use them

6.1 A cookie is a small file containing an identifier that is sent by a web server to a web browser and is stored on your computer/device by the browser. It enables our website to identify your computer as you view different pages on our website.

- 6.2 Cookies may be either 'persistent' cookies or 'session cookies'. A persistent cookie will be stored by a web browser and will remain valid until its set expiry date, unless deleted by the user before the expiry date; a session cookie, on the other hand, will expire at the end of the user session, when the web browser is closed.
- 6.3 Web storage, is a file containing an identifier (a string of letters and numbers) that is sent by a web server to a web browser and is stored on your computer/device by the browser. Web storage supports persistent data storage, similar to cookies but with a greatly enhanced capacity and is more secure
- 6.4 By using our websites, you consent to our use of cookies and web storage in accordance with the terms of this policy.
- 6.5 Cookies do not typically contain any information that personally identifies a user however they can allow websites and applications to store a user's preferences in order to present content, options or functions that are relevant to them. They also enable organisations to see information like how many people use the website and what pages they tend to visit.
- 6.6 We use cookies for the following purpose:
- **Analysis:** to analyse web traffic and performance using an analytics package. Aggregated usage data helps us improve the website structure, design, content and functions.
 - **Status:** to identify whether a user is signed in to our website
 - **Authentication:** to recognise when a user returns to our website and as they navigate the website
 - **Security:** to protect user accounts, including fraudulent use of login credentials
 - **Cookie consent:** to store your preferences in relation to the use of cookies more generally.
- 6.7 You can find more information about the individual cookies we use and the purposes for which we use them in the list below:
- **_ga:** A Google Analytics cookie used to distinguish users and sessions.
 - **_gat:** A Google Analytics cookie used to determine new sessions / visits.
 - **-gid:** A Google Analytics cookie used to determine whether the user was in a new session/visit.
 - **JSESSIONID:** This cookie is used to store a session / visit identifier to determine session/visit counts
 - **wfv_t_:** A wordfence cookie that tracks a users duration so that the pages can be grouped together.
- These are known as session cookies and are deleted when you leave the site.
- **Wordfence_verifiedHuman:** This cookie is used by Wordfence to verify whether the visitor is a bot or a human.
- 6.8 Where services such as Twitter or YouTube have been used on our websites, the providers will use cookies to run properly. You can view their privacy policy at (<https://help.twitter.com/en/rules-and-policies/twitter-cookies>) and <https://policies.google.com/technologies/cookies>.
- 6.9 Third Parties may also use cookies, over which we have no control. These are likely to be analytical/performance cookies or targeting cookies.
- 6.10 Users can use their web browser's cookie settings to determine how our website uses cookies. If you do not want our website to store cookies on your computer or device you should set your web browser to refuse cookies. However, please note that blocking all cookies may have a negative impact upon the usability of many websites and you may not be able to use all the features on our websites.

Unless you have changed your browser to refuse cookies, our website will issue cookies when you visit it.
